- (a) higher marks or score in Mathematics or Biology in CET;
- (b) higher marks or score in Physics in CET;
- (c) higher marks or score in Chemistry in CET;
- (d) higher percentage of marks in Physics, Mathematics or Biology and Chemistry added together at Board or Qualifying Examination.
- (e) higher percentage of marks in Mathematics or Biology in HSC or 10+2 Examination;
- (f) higher percentage of marks in Physics in HSC or 10+2 Examination.
- (g) higher percentage of marks in aggregate in HSC or 10+2 Examination.
